The Cit-e-Net **Online General-Payments** application provides an Internet-based capability for your organization to easily and quickly web-enable the online collection of premium payments, service renewals, donations, pledges and other various payment types that your organization might collect. Any department can have an Internet-based online collection capability using online credit card payments. The Cit-e-Net application enables client staff to create online payment types for their individual needs without requiring a web master or web programming knowledge. A customized version of the Cit-e-Net application can be implemented to provide a data-exchange import/export capability with other applications within your organization if desired.

THE PAYMENT PROCESS

Your organization selects the credit card merchant services processor that it desires to use for its credit card processing. Online credit card payments are processed immediately by your organization's designated credit card processor and are collected immediately by your organization directly from the credit card payer.

Cit-e-Net *is not* a 3rd-party payment collector, so there is no Cit-e-Net transaction fee or surcharge to either the organization or the payer for online payments transactions, and there is no delay in receipt of payment by your organization.

- Credit card account information *is not stored* by the Cit-e-Net application, Cit-e-Net or your organization.
- No additional equipment or software is required by your organization; the solution is web-based with Cit-e-Net.
